Guidelines & Precautions to be taken by Patients & their Families

1. All needy families have to follow the messages as per the missed calls and based on the Information available about Sanghs / Centers, they should approach only the Sanghs / Centers which are near to their Residence.
2. All patients' families have to contact Sangh's Representatives / Vihar Seva Group Coordinators for their emergency needs of the Oxygen cylinders.
3. All patients' family members have to personally go to Sangh / Centers to collect their cylinders with masks, gloves, sanitizer bottles, spanner and take utmost precautions which are required for handling cylinders which are used by Corona patients. This procedure has to be followed while collecting and returning the empty ones.
4. All patients' family members have to pay a security deposit of Rs 5,000 for 3 liters & Rs 10,000 for 10 liters capacity cylinders by Cheque/Cash for Sangh registered members & only Cash Deposit by unknown Sangh members.
5. All patients' family members must strictly use this facility under proper supervision of their family Doctors.
6. All patients' family members ensure the Return of the empty or filled, unused cylinders to Sanghs / Centers at the earliest & generally within 3 days. In other words, these cylinders must not be kept or stored without its genuine use so that other needy patients can avail of them for their emergencies.
7. Sangathan, Veer Foundation & Vihar Seva Group Members are not at all responsible for any consequences or mishap due to these cylinders.
